Program Terms and Conditions

In keeping with the authorization herein by the club member providing billing details above and a signature below, Montrose Hideaway Bed-and-Breakfast Retreat will process the authorized amount to the above-mentioned credit card under the following terms and conditions:

1. All nonrefundable funds will be placed on account under the club member's name for future use. (See Item 9 for refund exception details.) In exchange, the club member will automatically qualify for a minimum discount of 10% off reservations of any length, even during special-event and holiday dates when regular discount offers are excluded. This discount can be combined with the 10% military discount or a 10% referral discount for up to 20% off the total reservation, except during holidays and special-event dates, when 10% will be the maximum discount available. It cannot be combined with any other published offers.
2. The first installment will be processed by Montrose Hideaway immediately upon receiving the signed authorization form. Additional installments will be processed on or about the first of each month beginning with the next month.
3. The club member is agreeing to a minimum participation period of six months and a minimum monthly charge of \$25. In exchange, the club member can enjoy immediate savings as long as a copy of this form has been provided by the time the reservation is made. The club member can end participation at any time after the six months by providing written notice to stop future charges.
4. Montrose Hideaway agrees to provide an e-mail update to the club member after each installment to keep the guest current on how much is on account.
5. The club member can update billing information, change the amount to be processed and/or change the credit card to be used at any time by providing a new authorization form. The change will take effect with the next scheduled installment.
6. The club member may use the funds to pay for reservations for other guests. The 10% discount will be applied as long as the club member makes all reservation arrangements and signs the reservation confirmation for Montrose Hideaway's files.
7. Club members will still be required to pay a minimum of 50% of all reservations as a deposit and the balance on arrival in accordance to the inn's standard reservation policies. The deposit will be based on the discounted rate and funds on account will be used first before processing additional funds, if needed, to meet the deposit. The same procedure will be followed for the balance due at arrival.
8. In addition to using the funds for specific reservations, the club member may use funds to purchase customized Montrose Hideaway gift certificates, gift cards issued through bedandbreakfast.com that can be used nationwide, or for merchandise in the inn's gift shop. There are no discounts related to these uses of the funds, but they are offered as ways to budget for gifts or to use the funds at another inn if the club member finds he/she is unable to use the funds at Montrose Hideaway as originally intended.
9. The funds will be nonrefundable unless Montrose Hideaway closes, whether under current or future ownership. In the event of a closing, refunds will be issued based on unused funds as of the closing date of the business in the form of a bedandbreakfast.com gift card that has no expiration date and that can be used at hundreds of inns around the United States.
